2011 Agreement Terms & Conditions*

I, the undersigned, a University of Connecticut Neag School of Education student, hereby acknowledge the following terms and conditions regarding the use of a notebook computer ("Computer") supplied to me by the Neag School of Education ("NSOE"). The term of this agreement shall commence with the date below and end after either (i) a maximum of 4 academic semesters (including two summer semesters), or (ii) any change in my status as a Neag School of Education student.

The NSOE has represented the following to me:

1. The Computer is in working condition.
2. The Computer contains all hardware including other necessary peripheral equipment and required software.
3. The NSOE has afforded insurance for the Computer against damage and theft (details included in section on Damage & Theft)
4. The NSOE will provide ongoing on-site technical support for the duration of this agreement during hours posted on the NSOE Technology website. <http://www.education.uconn.edu/technology/AcademicTechnology>

**Fees:** I understand that enrollment in the Academic Technology Program for my degree and/or class is mandatory. The fee will remain as long as I am a NSOE student here in Storrs, on Co-op, or participating in a Study Abroad program. The semester fee for this computer will be \$465.00 for summer (1) 2011, summer (2) 2011, fall 2011 and spring 2012 making the total fee \$1860.00.

**My Responsibilities:**

1. I will use the Computer in accordance with NSOE policies on appropriate use of computer resources.
2. I agree that I do not own the computer, and thus, no title of ownership of any hardware or software is conveyed nor will I sell, lease, rent, mortgage, or in any way dispose of the interest in the system or any part and will keep the same free of liens, claims or charges of any kind whatsoever.
3. I understand this agreement is for the "right to use" only.
4. I will not permit any other person to possess or use this system.
5. I will not use, nor will I allow or cause the Computer to be used for any commercial purpose whatsoever.
6. I will not personalize the Computer with stickers, graffiti, markings, etc. in any way nor of any kind, whatsoever.
7. I agree to use the installed software only on this Computer. I will not copy, or allow to be copied, nor shall I reverse assemble or decompile same as such relates to copyright laws.
8. I shall immediately notify the NSOE, in writing, of any changes in my status as a University of Connecticut student, changes to my program or changes to my address and phone number during the period of this agreement.

**Damage and Theft:**

1. I bear the entire risk of loss, damage or theft to the system from any cause whatsoever until it is returned to the NSOE and a receipt is issued to me.
2. In the event of theft of the Computer, I agree to obtain a police report made within 24 hours of the earlier of either the occurrence or my discovery of the occurrence. I understand failure to do so could result in my having to pay the full cost of replacement of the Computer.
3. I also agree to notify the NSOE Technology Services Department within 24 hours after an incident of loss or damage of any kind.
4. I understand that the insurance coverage is limited to only one (1) theft OR (1) damage claim within any 12 month period. In addition, I may be charged an administrative fee of \$150.00 per occurrence.

**Return:**

I agree to return the Computer the earlier of either the end of this contract, graduation or such earlier termination of enrollment. The condition of the Computer shall be as the same as when I received it notwithstanding reasonable and commensurate wear and tear. I understand that failure to return the Computer **within 48 hours** of above mentioned conditions may result in my being liable for the replacement cost of the Computer which the NSOE shall have the ability to collect to the fullest extent of the law.

**Buyout:** If I choose to purchase my Computer at the end of this usage agreement, I will notify Genesis Capital in writing of my desire at least 30 days prior. Genesis will provide details of the process for transferring ownership to me. The NSOE will provide a mailing address for Genesis on its web site. The buy-out cost for the notebook computer has been set at \$420.00 plus CT sales tax.
